

**Callaway Golf - Gas Giveaway - Rebate Program**  
**Official Rules / Terms and Conditions**  
**Effective May 15, 2008**

**Excluded Product:** all products and merchandise not specifically defined above, including but not limited to Callaway Golf Big Bertha drivers, fairway woods, Squareway™ woods, hybrids, irons, golf balls, footwear, golf bags, golf gloves, umbrellas, caps, ball markers, divot tools, apparel, timepieces, rangefinders, eyewear/sunglasses, luggage, and any non-Callaway Golf branded products including those from Top-Flite®, Ben Hogan®, and/or Odyssey®. Any back-ordered, special ordered, or custom ordered drivers that are purchased within the Promotion Period must also be delivered to the consumer prior to the expiration of the Promotion Period. This Reward Program applies to Qualified Products purchased from Participating Authorized Retailers for consumer end-use only and not to products purchased for re-sale or promotional/charity/tournament or other group events.

2) Obtain your original cash register receipt (or packing slip from online purchases or reward redemption receipt for American Express Membership Rewards transactions) for the purchase of your Qualified Product (collectively "Original Proof of Purchase Document"). Original Proof of Purchase Documents from multiple Completed Redemption
